CHICAGO, LLC, a corporation, FULLER'S SERVICE CENTER, INC., a corporation, FULLER'S REAL ESTATE HOLDINGS, LLC, a corporation, DOUGLAS FULLER FAMILY, L.P., a partnership, D.A. FULLER CORPORATION, MARTIN CONTRERAS, as father, guardian and next friend of MARTIN CONTRERAS, JR. (hereinafter "CONTRERAS"), DOUGLAS A. FULLER, JR., and SUSAN FULLER GROENEWOLD, and in support thereof, state as follows:


COUNT I - WRONGFUL DEATH - FULLER'S CAR WASH, INC.

- 1. On July 17, 2023, and at all times mentioned herein, Defendant, FULLER'S CAR WASH, INC., was a corporation incorporated within the State of Illinois. Defendant's President and Secretary is Matthew Fuller with an address at 9124 W. 47th St., Brookfield, County of Cook, State of Illinois.
- 2. On and before July 17, 2023, Defendant, FULLER'S CAR WASH, INC., operated a corporate website which proffers to the public that FULLER'S CAR WASH, INC., does substantial business in the County of Cook, listing as Fuller's Car Wash Locations¹:



- 5. On July 17, 2023, and at all times mentioned herein, Defendant, FULLER'S CAR WASH, INC., owned a car wash located at 102 W. Chicago Avenue, Hinsdale, Illinois 60521.
- 6. On July 17, 2023, and at all times mentioned herein, Defendant, FULLER'S CAR WASH, INC., operated a car wash located at 102 W. Chicago Avenue, Hinsdale, Illinois 60521.
- 7. On July 17, 2023, and at all times mentioned herein, Defendant, FULLER'S CAR WASH, INC., managed a car wash located at 102 W. Chicago Avenue, Hinsdale, Illinois 60521.

- 10. On July 17, 2023, and at all times mentioned herein, Defendant, CONTRERAS, was a duly appointed actual agent and/or employee of Defendant, FULLER'S CAR WASH, INC., acting at all times within the course and scope of his actual agency and/or employment.

- 11. On July 17, 2023, and at all times mentioned herein, the aforementioned car wash owned, operated, managed, maintained and controlled by FULLER'S CAR WASH, INC., was located at or near the intersection of Chicago Avenue and Lincoln Street, and the exit of the car wash faced in a generally eastbound direction towards Lincoln Street.
- 12. On July 17, 2023, at approximately 2:30 p.m., Defendant, CONTRERAS, as a duly authorized agent and/or employee of Defendant, FULLER'S CAR WASH, INC., entered and operated a 2020 Jeep Wrangler which was exiting the aforementioned car wash and hit the accelerator.
- 13. On July 17, 2023, and at all times mentioned herein, the aforementioned car wash had no barriers that separated the exit of the car wash and the sidewalk adjacent to Lincoln Street.
- 14. On July 17, 2023, at approximately 2:30 p.m., Plaintiff's decedent, SEAN PATRICK RICHARDS, was lawfully walking along the sidewalk located on the west side of Lincoln Steet, located due south from its intersection with Chicago Avenue.
- 15. On July 17, 2023, at approximately 2:30 p.m., Defendant, FULLER'S CAR WASH, INC., by and through its duly authorized actual agent and/or employee, CONTRERAS, pressed the accelerator of the 2020 Jeep Wrangler causing it to proceed across a sidewalk, through a curb, a street parking spot, two lanes of traffic and another street parking spot on Lincoln Street, jump a curb, proceed across another sidewalk and ultimately crash into Fontano's Subs.
- 16. On July 17, 2023, during the course of events as delineated in Paragraph 15 of Count V of this Complaint at Law, the 2020 Jeep Wrangler being operated by Defendant, FULLER'S CAR WASH, INC., by and through its actual agent and/or employee, Defendant,

CONTRERAS, struck Plaintiff's decedent, SEAN PATRICK RICHARDS, a lawful and innocent bystander.

- 17. On July 17, 2023, and at all times mentioned herein, Defendant, FULLER'S CAR WASH, INC., individually, had a duty to operated its car wash in a safe and careful manner so as to avoid causing injury and/or death to third persons.
- 18. Specifically, prior to July 17, 2023, Defendant, FULLER'S CAR WASH, INC., was on notice of other instances where vehicles exiting the car wash had proceeded straight over the curb, through the sidewalk, and onto Lincoln Street, including, but not limited to:
 - a) In approximately July of 2007, a Jeep Grande Cheroke owned by Diana Newlin was taken to the aforementioned car wash. As it was exiting, an employee entered the vehicle and pressed the accelerator, causing the car to jump the curb, cross Lincoln Street, and crash into a pickup truck parked in front of Fontano's Subs, totaling the Jeep Grande Cheroke for which Defendant paid for in full;
 - b) Approximately a year prior to July of 2023, two vehicles rolled out of Fuller's Car Wash, crossed Lincoln Street, and t-boned a vehicle owned by Lauri Aldrich which was parked outside of Fontano's Subs. Upon information and belief, Ms. Aldrich specifically told the car wash that many bikers and pedestrians pass by Fuller's exit all day long and something needed to be done to make sure the area was safer, yet Defendant made no efforts to prevent this from happening again.
- 19. On July 17, 2023, and at all times mentioned herein, Defendant, FULLER'S CAR WASH, INC., was negligent in one or more of the following ways:
 - a) Did not have policies/procedures for the safe exit of vehicles from the car wash exit;
 - b) Instructed drivers to accelerate in order to remove vehicles from the car wash under conditions that created an unreasonable danger;
 - c) Allowed employees who were unfit to operate motor vehicles to enter vehicles with instruction to accelerate;
 - d) Did not have barriers to prevent vehicles from exiting the car wash parking lot towards Lincoln Street:
 - e) Repeatedly ignored prior occurrences which put Defendant on notice of the unsafe condition presented by its car wash;
 - f) Did not provide adequate training, instruction and experience to its agents and/or employees;
 - g) Caused an permitted an inexperienced employee to operated the subject Jeep Wrangler when Defendant knew, or reasonably should have known, that he was unfit to do so;

- h) Did not provide any visual or other types of warnings to pedestrians who were lawfully walking in the area of the car wash of the known dangers posed;
- i) Was otherwise careless and negligent.
- 20. On July 17, 2023, and at all times mentioned herein, Defendant, FULLER'S CAR WASH, INC., by and through its actual agent and/or employee, CONTRERAS, was negligent in one or more of the following ways:
 - a) Carelessly and negligently operated and controlled the 2020 Jeep Wrangler;
 - b) Carelessly and negligently failed to exercise the degree or care and caution that a reasonable person under similar circumstances would have exercised in the operation of the 2020 Jeep Wrangler;
 - c) Did not keep an adequate, or any, lookout during the operation of the 2020 Jeep Wrangler;
 - d) Operated and controlled the 2020 Jeep Wrangler at a speed that was greater than was reasonable in violation of 625 ILCS 5/11-601;
 - e) Failed to give audible warning with the horn, when such warning was reasonable and necessary, in violation of 625 ILCS 5/12-601;
 - f) Operated a motor vehicle in a reckless manner, in violation of 625 ILCS 5/11-503;
 - g) Operated and controlled a motor vehicle with a willful and wanton disregard for the safety of others, in violation of 625 ILCS 5/11-503(a);
 - h) Did not decrease speed so as to avoid colliding with a person, in violation of 625 ILCS 5/11-601;
 - i) Left legal roadways creating an unreasonably dangerous risk to those on a sidewalk;
 - j) Was otherwise careless and negligent.
- 21. As a direct and proximate result of one or more of the aforementioned acts and/or omissions, Plaintiff's decedent, SEAN PATRICK RICHARDS, sustained injuries which resulted in his death on July 20, 2023 at The University of Chicago Comer Children's Hospital located at 5721 S. Maryland Ave., Chicago, County of Cook, State of Illinois.
- 22. Plaintiffs, BRIAN RICHARDS and KRISTINE RICHARDS, are the duly appointed Independent Administrators of the Estate of SEAN PATRICK RICHARDS, and bring this action pursuant to the Wrongful Death Act of the State of Illinois, 740 ILCS 180/1 *et seq*.
- 23. On and after July 20, 2023, Plaintiff's decedent, SEAN PATRICK RICHARDS, left surviving him his parents, Brian Richards and Kristine Richards, as well as his siblings, Conor

Richards, Grace Richards and Finn Richards (a minor), all of whom have sustained damages including, but not limited to, grief, sorrow and emotional distress, loss of society, as well as other damages.

WHEREFORE, Plaintiffs, BRIAN RICHARDS and KRISTINE RICHARDS, demand Judgment in their favor and against Defendant, FULLER'S CAR WASH, INC., in an amount in excess of the jurisdictional limitation of FIFTY THOUSAND DOLLARS (\$50,000.00).

COUNT II – SURVIVAL ACT – FULLER'S CAR WASH, INC.

- 1-23. Plaintiff re-adopts and re-alleges Paragraphs 1-23 of Count I of this Complaint at Law as if fully set forth here in this Count II.
- 24. As a direct and proximate result of the aforementioned negligent acts and/or omissions of Defendant, FULLER'S CAR WASH, INC., Plaintiff's Decedent, SEAN PATRICK RICHARDS, sustained injuries of a personal and pecuniary nature prior to his death on July 20, 2023, including, but not limited to, pain and suffering, pre-impact fright and terror, and loss of a normal life, and had SEAN PATRICK RICHARDS survived he would have been entitled to bring an action for these injuries, and this action survives his passing.
- 25. Plaintiffs, BRIAN RICHARDS and KRISTINE RICHARDS, are the duly appointed administrators of the Estate of SEAN PATRICK RICHARDS, deceased, and bring this action pursuant to the Illinois Survival Act, 755 ILCS 5/27-6, et seq.

WHEREFORE, Plaintiffs, BRIAN RICHARDS and KRISTINE RICHARDS, demand Judgment in their favor and against Defendant, FULLER'S CAR WASH, INC., in an amount in excess of the jurisdictional limitation of FIFTY THOUSAND DOLLARS (\$50,000.00).

- 3. On July 17, 2023, and at all times mentioned herein, Defendant, 102 W. CHICAGO, LLC, owned a property located at 102 W. Chicago Avenue, Hinsdale, Illinois 60521.
- 4. On July 17, 2023, and at all times mentioned herein, Defendant, 102 W. CHICAGO, LLC, operated a property located at 102 W. Chicago Avenue, Hinsdale, Illinois 60521.
- 5. On July 17, 2023, and at all times mentioned herein, Defendant, 102 W. CHICAGO, LLC, managed a property located at 102 W. Chicago Avenue, Hinsdale, Illinois 60521.

- 17. On and before July 17, 2023, and at all times mentioned herein, Defendant, 102 W. CHICAGO, LLC, did not install barriers to separate the exit of the carwash and adjacent driveway from the sidewalk next to Lincoln Street.

- 18. On July 17, 2023, at approximately 2:30 p.m., Plaintiff's decedent, SEAN PATRICK RICHARDS, was lawfully walking along the sidewalk located on the west side of Lincoln Steet, located due south from its intersection with Chicago Avenue.
- 19. On July 17, 2023, at approximately 2:30 p.m., Defendant, 102 W. CHICAGO, LLC, by and through its duly authorized actual agent and/or employee, CONTRERAS, pressed the accelerator of the 2020 Jeep Wrangler causing it to proceed across a sidewalk, through a curb, a street parking spot, two lanes of traffic and another street parking spot on Lincoln Street, jump a curb, proceed across another sidewalk and ultimately crash into Fontano's Subs.
- 20. On July 17, 2023, during the course of events as delineated in Paragraph 19 of Count I of this Complaint at Law, the 2020 Jeep Wrangler being operated by Defendant, 102 W. CHICAGO, LLC, by and through its actual agent and/or employee, Defendant, CONTRERAS, struck Plaintiff's decedent, SEAN PATRICK RICHARDS, a lawful and innocent bystander.

 - i) Was otherwise careless and negligent.

- 26. Plaintiffs, BRIAN RICHARDS and KRISTINE RICHARDS, are the duly appointed Independent Administrators of the Estate of SEAN PATRICK RICHARDS, and bring this action pursuant to the Wrongful Death Act of the State of Illinois, 740 ILCS 180/1 *et seq*.
- 27. On and after July 20, 2023, Plaintiff's decedent, SEAN PATRICK RICHARDS, left surviving him his parents, Brian Richards and Kristine Richards, as well as his siblings, Conor Richards, Grace Richards and Finn Richards (a minor), all of whom have sustained damages including, but not limited to, grief, sorrow and emotional distress, loss of society, as well as other damages.

WHEREFORE, Plaintiffs, BRIAN RICHARDS and KRISTINE RICHARDS, demand Judgment in their favor and against Defendant, 102 W. CHICAGO, LLC, in an amount in excess of the jurisdictional limitation of FIFTY THOUSAND DOLLARS (\$50,000.00).

COUNT IV – SURVIVAL ACT – 102 W. CHICAGO, LLC

- 28. As a direct and proximate result of the aforementioned negligent acts and/or omissions of Defendant, 102 W. CHICAGO, LLC, both individually and by and through its agents, Plaintiff's Decedent, SEAN PATRICK RICHARDS, sustained injuries of a personal and pecuniary nature prior to his death on July 20, 2023, including, but not limited to, pain and suffering, pre-

impact fright and terror, and loss of a normal life, and had SEAN PATRICK RICHARDS survived he would have been entitled to bring an action for these injuries, and this action survives his passing.

29. Plaintiffs, BRIAN RICHARDS and KRISTINE RICHARDS, are the duly appointed administrators of the Estate of SEAN PATRICK RICHARDS, deceased, and bring this action pursuant to the Illinois Survival Act, 755 ILCS 5/27-6, et seq.

car washes, which included car washes in Western Springs (Cook County), Oak Lawn (Cook County), and Cicero (Cook County).

On and before July 17, 2023, and at all times mentioned herein, Defendant, FULLER'S SERVICE CENTER, INC. advertised themselves to residents of Cook County, inviting customers to visit their Service Center or any of the Fuller Car Wash Locations "Whether you are from Hinsdale or a surrounding community like Clarendon Hills or Western Springs, we invite you to visit Fuller's Service Center and any of our Fuller Car Wash locations." (https://www.fullersservicecenter.com/About-Us).
- 6. On July 17, 2023, and at all times mentioned herein, Defendant, FULLER'S SERVICE CENTER, INC., owned a car wash located at 102 W. Chicago Avenue, Hinsdale, Illinois 60521.
- 7. On July 17, 2023, and at all times mentioned herein, Defendant, FULLER'S SERVICE CENTER, INC., operated a car wash located at 102 W. Chicago Avenue, Hinsdale, Illinois 60521.
- 8. On July 17, 2023, and at all times mentioned herein, Defendant, FULLER'S SERVICE CENTER, INC., managed a car wash located at 102 W. Chicago Avenue, Hinsdale, Illinois 60521.

- 14. On July 17, 2023, and at all times mentioned herein, the aforementioned car wash had no barriers that separated the exit of the car wash and the sidewalk adjacent to Lincoln Street.
- 15. On and before July 17, 2023, and at all times mentioned herein, Defendant, FULLER'S SERVICE CENTER, INC., did not install barriers to separate the exit of the carwash and adjacent driveway from the sidewalk next to Lincoln Street.
- 16. On July 17, 2023, at approximately 2:30 p.m., Plaintiff's decedent, SEAN PATRICK RICHARDS, was lawfully walking along the sidewalk located on the west side of Lincoln Steet, located due south from its intersection with Chicago Avenue.
- 17. On July 17, 2023, at approximately 2:30 p.m., Defendant, FULLER'S SERVICE CENTER, INC., by and through its duly authorized actual agent and/or employee, CONTRERAS,

pressed the accelerator of the 2020 Jeep Wrangler causing it to proceed across a sidewalk, through a curb, a street parking spot, two lanes of traffic and another street parking spot on Lincoln Street, jump a curb, proceed across another sidewalk and ultimately crash into Fontano's Subs.

- 18. On July 17, 2023, during the course of events as delineated in Paragraph 17 of Count III of this Complaint at Law, the 2020 Jeep Wrangler being operated by Defendant, FULLER'S SERVICE CENTER, INC., by and through its actual agent and/or employee, Defendant, CONTRERAS, struck Plaintiff's decedent, SEAN PATRICK RICHARDS, a lawful and innocent bystander.

- 20. Specifically, on and before July 17, 2023, Defendant, FULLER'S SERVICE CENTER, INC., was on notice of other instances where vehicles exiting the car wash had proceeded straight over the curb, through the sidewalk, and onto Lincoln Street, including, but not limited to:
 - a) In approximately July of 2007, a Jeep Grande Cheroke owned by Diana Newlin was taken to the aforementioned car wash. As it was exiting, an employee entered the vehicle and pressed the accelerator, causing the car to jump the curb, cross Lincoln Street, and crash into a pickup truck parked in front of Fontano's Subs, totaling the Jeep Grande Cheroke for which Defendant paid for in full; and
 - b) Approximately a year prior to July of 2023, two vehicles rolled out of Fuller's Car Wash, crossed Lincoln Street, and t-boned a vehicle owned by Lauri Aldrich which was parked outside of Fontano's Subs.  - c) Did not keep an adequate, or any, lookout during the operation of the 2020 Jeep Wrangler;
 - d) Operated and controlled the 2020 Jeep Wrangler at a speed that was greater than was reasonable in violation of 625 ILCS 5/11-601;
 - e) Failed to give audible warning with the horn, when such warning was reasonable and necessary, in violation of 625 ILCS 5/12-601;
 - f) Operated a motor vehicle in a reckless manner, in violation of 625 ILCS 5/11-503;
 - g) Operated and controlled a motor vehicle with a willful and wanton disregard for the safety of others, in violation of 625 ILCS 5/11-503(a);
 - h) Did not decrease speed so as to avoid colliding with a person, in violation of 625 ILCS 5/11-601;
 - i) Left legal roadways creating an unreasonably dangerous risk to those on a sidewalk;



 - d) The managers/members/directors of each had a right to direct and govern the policy or conduct of the other members through Douglas A. Fuller, Jr. and Susan Fuller Groenewold;
 - e) The corporations and partnerships had a right to joint control and management of the property used in the enterprise; and
 - f) Those corporations and partnerships engaged in a sharing of both profits and losses.

14. That should Defendants, 102 W. CHICAGO, LLC, FULLER'S SERVICE

CENTER, INC., FULLER'S CAR WASH, INC., and FULLER'S REAL ESTATE HOLDINGS,

LLC, or any of them, be found liable for the injuries and damages to Plaintiff, then Defendants,

D.A. FULLER CORPORATION and DOUGLAS FULLER FAMILY, LP are vicariously liable for

such conduct, and are liable for any judgment rendered in this case.

WHEREFORE, Plaintiffs, BRIAN and KRISTINE RICHARDS, as Independent

Administrators of the Estate of SEAN RICHARDS, deceased, demand judgement against

Defendants, D.A. FULLER CORPORATION and DOUGLAS FULLER FAMILY, LP, in an

amount in excess of FIFTY THOUSAND DOLLARS (\$50,000.00).
